

on the alliance structure

confirmed

- Alliance Model: **pre-formed** group bids only
- Proposed Timescales
- Alliance Manager / infrastructure support:
 - *CCPS support to submit SG funding bid to cover initial transition period; or*
 - *Funded from £20m HSCP budget allocation if bid unsuccessful*

pending decisions (sept)

- Financial Management / Governance arrangements;
- Contract management arrangements;
- Interim Arrangements for Legacy contracts post-award.




2. Refreshing

on the principles the alliance
will commit to

Alliance Principles



- to assume collective responsibility for all of the risks involved in providing services under this Agreement;
- to make decisions on a 'Best for Service' basis;
- to commit to unanimous, principle and value based-decision making on all key issues;
- to adopt a culture of 'no fault, no blame' between the Alliance Participants and to seek to avoid all disputes and litigation (except in very limited cases of wilful default);
- to adopt open book accounting and transparency in all matters
- to appoint and select key roles on a best person basis; and
- to act in accordance with the Alliance Values and Behaviours at all times.



3. Framing

the core values that
will guide the alliance

- **Personalised:** support should be open-ended, persistent, flexible and coordinated, and work with the ‘whole-person’ and/or ‘whole-family’ - and take into account the underlying causes of complex needs and the challenging behaviours that can be associated with them.
- **Deinstitutionalisation:** as far as possible, people should have the option of staying in mainstream housing, rather than specific, separate institutions.
- **Reintegration:** the focus should be on enabling people to access mainstream employment and other opportunities and engage in other ‘ordinary’ social settings.
- **Asset-based:** interventions should focus on people’s strengths, enabling them to build a meaningful and fulfilling life in the face of ongoing challenges and realise their potential.
- **Poverty-informed:** the financial and material hardship that people face should be directly addressed, rather than only focusing on their social or personal needs or behavioural issues.
